It captures a the full scope of your academic and highlights the most relevant skills, comprehensive overview of a candidate's professional history. It typically includes achievements, and experiences for a education, competencies, professional detailed descriptions of education, **specific job.** Unlike a CV or UN-style experience, and demographic information research, publications, presentations, profile, a résumé is not meant to list everything you've done—it's a strategic to ensure consistency and comparability affiliations, and other credentials. CVs are across applicants. most often used in academia, research, marketing tool that showcases how your and international organizations like the UN, background aligns with the employer's where a complete record of your career is needs, typically in 1-2 pages. necessary.

 - Formatting goes a long way!
 - Add metrics using the "Achieved X by doing Y using Z" Framework
- Conduct Industry Research
 - Tailor resume to target industry
- Make minor adjustments for "Role" & "Professional Summary"
 - Optimize top 1/3 of your document
